

## **Terms and Conditions**

### 1. General

- 1.1. The competition is run by Richmonds Plumbing & Heating Merchants Limited (the "Company").
- 1.2. The name of the competition is the Richmonds Results Predictor and Prize Draw June/July 2019 (the "Competition").
- 1.3. The Competition will be run in two parts:
  - 1.3.1. the Results Predictor; and
  - 1.3.2. the Prize Draw.
- 1.4. The Competition will run from Tuesday 11 June 2019 (the "Opening Date") to Saturday 6 July 2019 (the "Closing Date").
- 1.5. All entries must be received by the Company at one of its Branches by no later than 12pm on the Closing Date.
- 1.6. Richmonds Employees are not eligible to enter the Competition.
- 1.7. The Company reserves the right to update or amend these terms and conditions at its sole discretion at any time on or prior to the Closing Date.

### 2. Results Predictor

- 2.1. To enter the Results Predictor:
  - 2.1.1. the entrant (or the entrant's business) must make a purchase of over £5 on each day of entering the competition at any of our Trade Counters between the Opening Date and the Closing Date; and
  - 2.1.2. the entrant must complete a Results Predictor, which are available from any of our Trade Counters throughout the Competition.
- 2.2. A Results Predictor relates to the next football game day following the date of purchase, as specified by the Company.
- 2.3. Subject to clause 2.1, the entrant shall be entitled to one Results Predictor per day.
- 2.4. Entrants who correctly predict the match results will receive a voucher entitling the bearer to £5 off INSTINCT Trade Tools Range (the "Voucher"). The Voucher is subject to a minimum purchase of £10.
- 2.5. The Voucher is valid for use at any of the Company's Branches until 31.07.19.
- 2.6. There is no cash alternative for the Voucher.

### 3. Prize Draw

- 3.1. Correct Result Predictors will be entered into the main Prize Draw.
- 3.2. There is no limit to the number of entries per person into the main Prize Draw.
- 3.3. The Prize Draw will be drawn by the Company on Monday 8 July 2019 (the "Draw Date").

- 3.4. There will be seven winners of the Prize Draw one winner per Branch of the Company.

  - 3.5.2. a £30 Love2shop voucher (the "Alternative Prize").

- 3.7. Prizes are subject to availability. The Company reserves the right to replace the Main Prize or the Alternative Prize with an alternative prize of equal or higher value if it is necessary to do so due to circumstances outside the Company's control.
- 3.8. There is no cash alternative for the Main Prize or the Alternative Prize.

## 4. Winners

- 4.1. The Company will identify the winner(s). The Company's decision is final.
- 4.2. The Company will contact the winner(s) as soon as possible after the Draw Date, using the telephone number provided by the entrant on their Results Predictor form.
- 4.3. If the winner(s) cannot be contacted within 14 days of the Draw Date, the Company reserves the right to offer the Main Prize or the Alternative Prize to another entrant of the Competition.

## 5. Data Protection

- 5.1. The Company will use the name and telephone number provided by the entrant on their Results Predictor form to contact the Competition winner(s).
- 5.2. The Company uses the personal data provided by the entrant on their Results Predictor form to:
  - 5.2.1. conduct the Competition in accordance these competition terms and conditions; and
  - 5.2.2. as set out in our Privacy and Cookie Policy (a copy of which is available on our website or on request from our Trade Counters).

### 6. Jurisdiction

6.1. The Competition terms and conditions shall be governed by, and construed in accordance with, the laws of Scotland and the entrant(s) and the Company irrevocably agree that the courts of Scotland shall have non-exclusive jurisdiction to settle any dispute or claim arising out of, or in connection with, these Competition terms and conditions, their subject matter or formation (including non-contractual disputes or claims).
