

## Terms and Conditions

### 1. General

- 1.1. The competition is run by Richmonds Plumbing & Heating Merchants Limited (the “**Company**”).
- 1.2. The name of the competition is the Richmonds Ideal Free Boiler Prize Draw May to July 2026 (the “**Prize Draw**”).
- 1.3. The Prize Draw will run from 1 May 2026 (the “**Opening Date**”) to 31 July 2026 (the “**Closing Date**”).
- 1.4. All entries must be received by the Company at one of its Branches by no later than 5pm on the Closing Date.
- 1.5. Richmonds Employees are not eligible to enter the Prize Draw.
- 1.6. The Company reserves the right to update or amend these terms and conditions at its sole discretion at any time on or prior to the Closing Date.

### 2. Prize Draw

- 2.1. Each Ideal Boiler purchased from the Company from the Opening Date to the Closing Date will earn one entry into the Prize Draw.

- 2.6. The Prize is subject to availability. The Company reserves the right to replace the Prize with an alternative prize of equal or higher value if it is necessary to do so due to circumstances outside the Company’s control.

- 3.2. The Company will contact the winner as soon as possible after the Draw Date, using the contact details provided by the entrant to the Company.
- 3.3. If the winner cannot be contacted within 14 days of the Draw Date, the Company reserves the right to offer the Prize to another entrant of Prize Draw.

### 4. Data Protection

- 4.1. The Company will use the name and telephone number and/or email address provided by the entrant to contact the Prize Draw winner.

- 4.2. The Company uses the personal data provided by the entrant to:
